# **Statement of Qualifications**

I am an Accident Reconstructionist with Stidham Reconstruction and Investigation LLC. I am also a commercial vehicle safety consultant and a Drug Recognition Expert (DRE)/DUI Instructor. I have been reconstructing accidents and investigating drunk and drugged driving incidents for over 20 years.

I began my career in the U.S. Army as a Military Police officer and assigned to the Traffic Investigations Unit at each assignment, attaining the rank of Sergeant. In the military I also operated several types of military style commercial vehicles, such as a three-quarter ton, one-ton trucks, and High Mobility Multipurpose Wheeled Vehicles (HMMWV). I also operated these vehicles with different types of trailers to include pintail, bumper, and gooseneck hitches.

I first served at Fort Richardson, Alaska where I was assigned to law enforcement duties for the installation. I then transferred to Fort Lewis, Washington where I served as a traffic accident reconstructionist. I later transferred to Camp Hiahleah in Pusan South Korea where I was assigned as the Non-Commissioned Officer In Charge (NCOIC) of the Traffic Investigations Unit for the southern region of South Korea. After completing my tour of service in Korea, I was transferred to Fort Carson, Colorado where I was assigned as a traffic accident reconstructionist and completed my military service.

After my military service was completed, I joined the Denver Police Department in Denver, Colorado. During my career with the Denver Police Department, I was assigned to the Accident/DUI unit and served as an accident reconstructionist and DUI enforcement officer. I later transferred to the Phoenix Police Department and then returned to Colorado as a Colorado State Trooper. As a Colorado State Trooper, I was certified to inspect and enforce the Federal Motor Carrier Safety Administration Rules and Regulations in addition to my other duties. I later transferred to the Garden City Police Department in Kansas. During my career with the Garden City Police Department, I obtained the rank of Master Patrol Officer (MPO), Corporal (CPL) and Sergeant (SGT) and oversaw the Motorcycle/Traffic Unit. Beyond my normal duties, I enforced the FMCSA CMV regulations and I also served as a Drug Recognition Expert (DRE) Instructor, Accident

Reconstructionist and police motorcycle instructor. I developed and taught a community outreach program for advanced motorcycle safety riding techniques.

I have also worked as a professor for National American University teaching criminal justice and business courses. I continue to work as an Instructor for the Institute for Police Technology and Management (IPTM) for accident reconstruction courses.

I have several degrees to include an AS in Agricultural Business from Garden City Community; a Bachelor of Science in Criminal Justice from Central Christian College of Kansas; A Masters in Business Administration and a Masters in Management from National American University. I am currently working on finishing my Ph.D. with Waldon University, focusing on the causation of legislation of marijuana efforts on traffic accident fatality increases.

I began my accident reconstruction and DUI training in 1997. I continued with basic collision training with the Washington State Patrol. I then followed that with Advanced and Technical Reconstruction from the Rocky Mountain Institute for Transportation Safety (RMITS) and took these courses again as a Colorado State Trooper. I also have specialized training in Auto vs. Pedestrian reconstruction, Motorcycle Accident reconstruction, and Commercial Motor Vehicle Accident reconstruction. Beyond accident reconstruction, I am also a police RADAR/LIDAR instructor, a Master Instructor for Narcotics Field Testing, and a Drug Recognition Expert (DRE) instructor. I have also been instructing Advanced Roadside Impaired Driving Enforcement (ARIDE) classes, Standardized Field Sobriety Test (SFST's) classes, DRE classes, along with motorcycle training and safety courses for police officers and civilian riders.

I am also an accredited Accident Reconstructionist with the Accreditation Commission for Traffic Accident Reconstruction (ACTAR). I am also a member of the National Association of Profession Accident Reconstruction Specialists (NAPARS) and the Midwest Association of Technical Accident Investigators (MATAI).
